EXIT 10B BROAD STREET

KEEP RIGHT FOR APPROXIMATELY 2.1 MILES

CONTINUE EAST (RIGHT) AND CROSS OVER RAILROAD TRACKS

PASS THE MAIN SHERIFF'S OFFICE AND CONTINUE LEFT AT THE CURVE

EXIT 36 CREOLE/CAMERON

CROSS OVER RAILROAD TRACKS

TURN RIGHT AT THE LIGHT ONTO HIGHWAY 90

TURN LEFT ONTO E BROAD STREET
